LW/21/0139 Response: 25.05.21	High Trees, Lower Station Rd., Newick, BN8 4HT	To construct an oak carport to house two cars with tiled roof to match the existing property with wood cladding on three sides. CPC support this application subject to the correct clarification of the property name; High Trees or Kybo. Proposed by Cllr Olbrich, seconded by Cllr Tregenza. All in favour.
LW/21/0144 Response: 25.05.21	6 The Martletts, South Chailey, BN8 4QG	Single storey rear extension. CPC do not object to this application. They do however have reservations about the flat roof and would prefer to see a pitched roof that would improve the design and increase longevity. Proposed by Cllr Jordan, seconded by Cllr Olbrich. All in favour.
LW/21/0162 Response: 17.05.21	The Vines, Station Rd., North Chailey, BN8 4HE	Proposed replacement of garage to include an office. CPC support this application subject to a S106 being applied to ensure that the proposed construction remains as part of the existing property. Proposed by Cllr Olbrich, seconded by Cllr Cornwall. All in favour.
