

## **Chailey Parish Council**

## **Minutes**

A meeting of Members of the Chailey Parish Council Planning & Environs Committee was held on Tuesday 7<sup>th</sup> June 2016 in the Reading Room, Chailey Green commencing at 7.30 pm.

**16/054 Apologies for absence:** Cllr. V Harrison

16/055 Verbal representations by members of the public: none

**16/056 Declarations of Interest by Councillors**: Cllr. Evans advised Councillors that he had written in a personal capacity to oppose application LW/16/0336. It was agreed that this did not preclude his taking a full part when this application was considered.

16/057 Items not on the agenda considered as a matter of urgency:

**Tree works:** the Clerk advised Councillors that an application for tree works had been received where the time for response was short. Councillors considered the application (TW/16/0046) for work to be carried out on three oak trees at 7 The Martletts, South Chailey and resolved that they had no objection to the proposed works, as long as they were carried out with the agreement and under the supervision of Lewes District Council's Tree Officer.

**Sports Pavilion**: Cllr O'Conor briefed Councillors on his visit with a builder to the Sports Pavilion. He recognised that this was a matter for the Full Council, and he would raise it again at the next meeting, but he advised Councillors that, in his view the money that would need to be spent repairing the building whilst, at the same time, ensuring it complied with all relevant requirements (for example under Disability Discrimination legislation) would far exceed the funds available. In his view the Council needed to take its own professional advice. After further discussion the Clerk was asked to identify and instruct an appropriate Chartered Building Surveyor to advise the Council on the present position and on what could/should be done going forward.

**16/058 Approval of minutes:** Cllr. Millam joined the meeting at this point. The minutes of the meeting of the Planning & Environs Committee held on 10<sup>th</sup> May 2016 were approved unanimously and signed by the Chairman.

**Note:** LW/16/0336: Councillors resolved that they had no objection to this application, subject to the change requested (if approved) not causing additional traffic movement during night-time hours. Councillors noted that condition 7 of the planning consent granted under reference LW/13/0490 (as amended by LW/14/0616) restricts to 60 the number of HGV movements that can take place between 21.00 and 06.00. Councillors would not support the current application if its effect was to cause additional traffic movements over that already permitted. Councillors pointed out that, although the site concerned is not in Chailey but in Newick, its location means that activity (especially that occasioned by vehicle movements to and from the site) has considerably more effect on the residents of Chailey than it does on the residents of Newick.
